**CLUB PURPOSE:**

To promote, direct, support and encourage competitive amateur cycling of club members at the local, state, national and world levels. To raise funds for the benefit of the club's general membership and to support the club's racing members. To solicit new members from the regional cycling community through written advertisement, verbal contact, and by each member maintaining a positive, friendly but competitive image when wearing the CA Pools Racing Team uniform.

**CLUB RACE:**

The USCF requires clubs to sponsor at least one race per year and the CA Pools Racing Team race for 2009 is already in the planning stages. The success of this race determines how much money can be spent for member reimbursements and support. It is the board's intentions to reimburse Cat. 3 and higher category riders two races per month, and Cat. 4/5s one race per month (\$20 per race with a total of \$40 per month). A high caliber road race like ours requires a great deal of staffing. Working for this race either before, during, or after the event is a **requirement** of each club member.

**RACING REIMBURSEMENT PROGRAM: (please read completely)**

**Race:** Funding for reimbursement is dependent upon club funds and individual agreements between riders and the team's Board of Directors. Any other anticipated race expenses such as out of area travel shall be negotiated with the team's Board of Directors.

**Qualification for Reimbursement:** The following requirements apply: 1) Work the club race-no exceptions. Note: Qualification lasts one year (one racing season). 2) Wear the current year's jersey when racing. 3) Wear the current year's jersey when accepting awards. 4) Have CA Pools Racing listed as your team on your racing license.

**Limitations:** Total dollar amounts available for reimbursement are dependent on the financial success of the race and the club as a whole. The reimbursement policy may be modified by the Board of Directors. Modifications will be posted on the team's website/Forum. Recreational members are not eligible for the racing reimbursement program.

**Membership Discounts:** Members will be eligible for product discounts as they become available.

### RELEASE:

Notice: This release form is a contract of legal consequences. Read it carefully before signing. In consideration of the acceptance of my application for membership in CA Pools Racing, I hereby freely agree to and make the following contractual representations and agreements.

I fully realize the dangers inherent to bicycle riding and fully assume the risks associated with such activity, including by way of example and not limitation, the following: the dangers of collision with pedestrians, vehicles, other riders, and fixed or moving objects; the dangers arising from surface hazards, equipment failure, inadequate safety equipment, and weather conditions; and the possibility of serious physical and/or mental trauma of injury associated with athletic cycling.

I hereby waive and hold harmless, release and discharge for myself, my heirs, executors, administrators, legal representatives, assigns and successors in interest (hereinafter collectively "successors") any and all rights and claims which I have or which may hereafter accrue to me against CA Pools Racing, the sponsors of the Club, the United States Cycling Federation and its affiliates through or by which the activities will be held for any and all damages which may be sustained by me directly or indirectly in connection with or arising out of my participation in or association with athletic cycling.

I agree for myself and successor, that the above representations are contractually binding, and are not mere recitals, and that I or my successors assert my claim in contravention of this agreement, I or my successors shall be liable for the expenses (including legal fees) incurred by the other party or parties in defending, unless the other party or parties are finally adjudged liable on such a claim for willful and wanton negligence. This agreement may not be modified orally, and waiver of any provision shall not be construed as a modification of any other provision herein or as consent to any subsequent waiver or modification.

PARENT OR GUARDIAN of a minor: I as a parent or guardian of the above named minor, hereby give my permission for my child or ward to participate in athletic cycling, and further agree individually and on behalf of my child or ward, to the terms of the above.

As a condition of membership in CA Pools Racing --

- I do hereby agree to and understand the above requirements.
- I will wear a helmet when riding a bike and wearing the club jersey.
